Minutes:

Commissioner Letham asked if there were questions or comments on the prepared minutes from April 25 and May 9 28, 2023 meetings.

Commissioner Foster made a motion to approve the minutes as presented.

Impact Fees Resolution;

Land Purchase Contract;

The Fire Commissioners approved and signed a contract for a land purchase agreement for the property with Legal Description as LOTS 15 & 16 BLK 4 TETONIA TOWNSITE SEC 28 & 29 T6N R45E. The closing date is scheduled for June 1, 2023.

Key Private Investment:

Kurt Daniels with Edward Jones asked the Commission what are the expectations and services needed from the advisory firm? The Commissioners would like to have quarterly reports in person and monthly statements. The Commission asked if the management fees could be lowered. Kurt said the fees could be lowered to about 62 basis points. Kurt will check with legal team to make sure EJ qualifies as an investment firm with Idaho Statue. No decision was made by the Fire Commissioners.

Budget FY 2024:

The proposed budget draft includes a COLA adjustment of 3% per Union Contract; The operating budget has been updated as well. The CIP in April was at 5 %. Aaron Stiny asked if the Commissioners would consider covering the health insurance premiums for employees at 100%. Next work session has been scheduled for June 13.

Chief Maltaverne met with Teton Ridge Ranch Manager and discussed emergency operations plans. Chief Hoyle went to Braun NW and toured the building plant. We signed a contract with a new learning system, Lexipol; Refreshing Trainings are in process to prepare for WL Season. Chief is working with the County on Active Response Killer Plan. Chief met with Dan Reye to follow up on IT Contract.
