Minutes:

Commissioner Letham asked if there were questions or comments on the prepared minutes from September 26, 2023 meeting.

No questions or comments were made.

Commissioner Foster made a motion to approve the minutes as presented. Commissioner Borbet seconded the motion.

Claims:

Ascent Retirement:

Brad Christensen joined via Zoom. He presented the investment strategy for the Fire District. O copy of the portfolio is attached to the minutes. He will be presenting quarterly reports going forward. He estimates an average of 4-5% yield return on the portfolio.

IT Update:

There is a draft contract for IT services that the County would provide the Fire District. The contract would start sometime in February 2024. For the time being, Greg Adams is providing IT services to the district as a contractor at an hourly rate.

Dispatch Contract:

The Fire Commissioners reviewed the contract and requested some changes to the contract:

- 1. Switch from monthly payments to quarterly payments.
- 2. The TCSO will provide their services on 24/7 hour basis.

Bathroom Remodel:

Commissioner Letham will start drawing some plans for the bathroom addition.

Chief's Report:

Chief Maltaverne met with City of Driggs to discuss future plans for the land that was purchased. The City will put out and RFQ for to study and develop building plans for the land. Chief Maltaverne would like to request an appraisal for the Station in Driggs.
